CENTRAL ARIZONA DENTAL SOCIETY FOUNDATION - MISSION OF MERCY (CADSF AZMOM) IS A LARGE, TWO-DAY DENTAL CLINIC. IN 2016, OUR VOLUNTEERS PERFORMED OVER 14,007 SEPARATE DENTAL PROCEDURES ON 1,798 INDIVIDUAL PATIENTS. THE CLINIC AND RELATED SERVICES ARE PROVIDED AT NO COST TO INDIVIDUALS WHO CANNOT ACCESS AND/OR AFFORD DENTAL CARE. THE POPULATION OF PATIENTS PRIMARILY CONSISTS OF THE WORKING POOR IN CENTRAL ARIZONA. APPROXIMATELY, 1,717 VOLUNTEERS COME TOGETHER 315 OF WHOM WERE DENTISTS AND PROVIDE BASIC DENTAL CARE AND SERVICES TO PEOPLE ON A FIRST COME, FIRST SERVED BASIS. THE TOTAL DOLLAR VALUE OF THE FREE SERVICES TOTALED APPROXIMATELY \$2.1 MILLION, \$240,000 IN VISION AND APPROXIMATELY \$13,000 IN MEDICAL SCREENING. THIS WAS THE FIFTH YEAR OF PROVIDING THIS TWO-DAY CLINIC.
